Dr. Amy Catlin-Jairazbhoy, Adjunct Professor, UCLA Herb Alpert School of Music

"Professor Amy" is an Adjunct Professor of Ethnomusicology at the UCLA Herb Alpert School of Music. Her research, writing, teaching, curatorial activities and multi-media publications often have an applied focus, aimed at community development of minority traditions, especially in diasporic settings. In particular, Amy's research involves the classical and non-classical musics of South and Southeast Asians and Asian-Americans. She has received funding for her numerous research projects across the globe from the NEA, NEH, Fulbright and the American Philosophical Society. Amy studied piano, voice and musicianship at the Peabody Conservatory. She has her master's in music from Yale and Ph.D. from Brown University.

Kaitlyn Chen, EXPLORE Alumna & Temple City High School Senior

With an early and strong passion for film, Kaitlyn aspires to study film and graphic design at University of Southern California. She is well on her way to achieving this goal, with her excellent academic record, abundance of extracurricular and volunteer activities (many served in a leadership capacity), and most recently, after completing an IEA EXPLORE summer externship. In the summer of 2017, Kaitlyn received mentorship from Dr. Amy Catlin-Jairazbhoy of the UCLA Herb Alpert School of Music. This mentorship involved research at "Professor Amy's" Aspasia Media for Intercultural Education, where she learned methods of metadata production concerning field recordings and editing original audiovisual materials in preparation for further research and publication. By the completion of the externship, Kaitlyn and Professor Amy together had worked at the challenging task of editing an hour-long video featuring a capoeira performance. She considers her EXPLORE experience to be life-changing, and is eternally grateful for the continued guidance, mentorship and support from Professor Amy and IEA staff. Community Advocate Award Jason & Sandy Roberts



Jason and Sandy Roberts have worked to ensure the needs of highly able learners are met in Pasadena Unified. Initially coaching elementary and middle school students in math, Jason and Sandy launched Math Academy to provide gifted middle and high school students with the skills and insight needed to excel in honors math and science at the most elite universities. Math Academy partners with Pasadena Unified in reaching students starting in 6th grade and offering them sequenced math coursework that culminates in completing Calculus in 8th grade. With a mathematics degree from University of Chicago, Jason has launched technology startups and built high-frequency trading systems. He designed and developed much of Uber's original real-time and global technologies. Sandy has spent the last ten years on nonprofit boards, holding leadership positions with Junior League and Pasadena Educational Foundation. With an economics degree from University of Chicago, she shares her love of math by teaching at the Math Academy and fundraising for the organization.



Educator Award: Tony Travouillon, Ph.D.

Since 2011, Tony has been delighting gifted young minds through his IEA Academy classes. According to one parent of a student in Tony's Astronomy class, "Mr. Tony inspired my child with his passion and knowledge of science and made learning fun." Teaching classes like Physics, Electrical Circuitry and Astronomy, Tony helps students explore the universe and learn how to build electrical circuits. An astrophysicist, he is a System Scientist at Thirty Meter Telescope Observatory, where he conducts experimental research on atmospheric turbulence and its repercussions for astronomy, image degradation, adaptive optics and interferometry. Since receiving his Ph.D. in astrophysics at the University of New South Wales, Tony has remained devoted to sharing his knowledge and experience with others. He holds a Visiting Associate position at Caltech and is an Adjunct Professor at College of the Canyons.





IEA Programs & Services

The Institute for Educational Advancement (IEA) encourages gifted children and their families to pursue their intellectual potential and advocate for their individual needs. Our programs and services provide gifted children, ages 2-18, with access to rigorous intellectual offerings, individualized learning opportunities, qualified mentors and accepting communities they would not otherwise find in traditional school systems.

IEA's four primary programs have been created to nurture the needs of gifted learners at different stages of their intellectual and personal development:

- **Academy** offers a menu of enrichment courses to K-8 students.
- **EXPLORE** matches gifted high school students with professors, business professionals, scientists, lawyers and doctors who mentor participants as they conduct research and work in real career settings.
- The **Caroline D. Bradley Scholarship** awards gifted seventh graders a four-year high school scholarship and personalized counseling and guidance.
- **Yunasa** and **Yunasa West** are summer camps to help gifted youth ages 10 to 15 pursue personal growth and balance.

IEA builds on our programs by providing additional services, including:

- **Professional Development** and **Consulting** to families and educators to guide them in the optimal educational fit for their students, learn about best practices in the identification and teaching of gifted learners and explore methods for evaluating student growth. Free monthly **Gifted Support Group** meetings support these efforts;
- An online catalog of resources in our **Gifted Resource Center**; and
- Our **Public Policy Initiative** brings together national experts to ameliorate the gap in gifted services in our school systems.

IEA's whole-child approach is unique in that our programs and services promote intellectual, physical, spiritual, emotional, and social growth. Many gifted learners within the IEA community will go on to contribute to the advancement of society through scientific, entrepreneurial, legal, creative and humanitarian work.






